#### SUMMARY DESCRIPTION

This position is an exciting addition, with further growth potential, to the Our City Forest (OCF) team! Supported by the President & CEO/Fund Developer, and a team of dedicated staff, the Climate Action Director will oversee OCF's operations for San José area urban forestry programs and services. They will oversee program/team managers for tree planting, tree care, nursery, and job corps. The Climate Action Director will ensure grant and policy compliance, monitor work plans, prepare reports, assess and manage resources, ensure adequate training and safety measures, and help create a culture in support of ongoing programmatic excellence.

#### **KEY RESPONSIBILITIES**

#### Work Plans and Contract Deliverables

- Oversees the development and tracking of the annual OCF work plan and budget
- Oversees grant/contract agreements, including deliverables, reports, budgets tracking
- With support from the Field Operations Manager and Arborist, oversees the timely execution and management of planting grants, fleet, safety policies, and facility operations
- With support from the OCF AmeriCorps Grant Officer, oversees successful completion of grant continuation and deliverables such as enrollment, retention, and reporting
- Communicates regularly with grantor agencies regarding current and future agreements

#### Staff Management & Support

- Supports and assesses the work of direct reports and progress towards goals
- · Assesses progress and recommends changes to strategies, staffing, etc, as needed
- · Oversees hiring for new positions or replacement hires and conducts evaluations
- Ensures accuracy of program data management and draft reports

Since 1994, and largely focused on environmental justice and creating the next generations of urban forestry experts, OCF has secured grants and donations to mobilize 150,000+ volunteers and train 600 low-income young adults to assist neighborhoods, schools, agencies, and businesses in planting and establishing approximately 75,000+ large shade trees and 25,000+ shrubs under the watch of OCF's professional staff team of arborists and urban foresters. A signed stewardship agreement is obtained for every tree through OCF's community-based stewardship program, and follow-up is provided for 3 years to help ensure successful establishment. OCF also provides an array of related services including tree care, volunteer training, tree cultivation, information and referral, and environmental education.
